Board Members Meet in Vancouver for Mid-Year Discussions

On Thursday, June 10th, through Saturday, June 12th, the IALEP Executive Board members met in beautiful, temperate, Vancouver, British Columbia in Canada for the mid-year meeting.

One of the major topics of conversation was firming up some of the details for the exciting, upcoming 2010 IALEP conference in Scottsdale, Arizona, and how some of the new innovations we are exploring with that conference can carry through to future conferences to make everyone's learning experience even richer.

For example, we are exploring having a single day exhibit rate for local retail vendors to allow them to offer local goods and wares at the conference, capitalizing on the area's popular items and offering conference attendees a convenient, welcome way to access memorabilia. Since this is being scheduled for a one-day event, space can be made available to allow the possibility of an academically-related poster presentation from a local Scottsdale area college, allowing students to network with attending IALEP members and present their research topics.

In the same subject area, we voted to charge the attractive fee of \$15 per breakout session for students to allow them to attend the sessions they wish for extra credit or interest, and to offer a

special half-day rate for Southwest Chapter members who are volunteering their time to assist with the conference.

Continuing in the conference frame of mind, Beth Neilson and her 2011 Conference Committee members gave a super presentation on the possibilities Vancouver offers as a conference venue for IALEP. You'll hear more about Vancouver's beauty and offerings this fall in Scottsdale. The Board saw several hotels, and we are working to make the experience both economical and memorable, with the Board voting to pursue primary negotiations with the Four Seasons.

The plans for the fall Planner's Course are well underway, with Training Coordinator, Barry Horrobin hard at work setting it up for November 15th through 19th in Columbus, Ohio. Possible venues are also being explored for the April, 2011 course. The course continues to be in high demand, not only with IALEP members, but internationally as well. Barry and Pete Bellmio continue to work with the United Nations Police to set up the Planner's Course training presentation modified to meet the U.N.'s needs. Once details are worked out on both sides, this will be a tremendous opportunity for IALEP. *(Continued on page 2)*

The following items were also discussed at the business meeting:

- Acceptance of credit card payment for membership and conference fees, to be pursued on a one year trial basis;
- The approval of the application by the Ontario Association of Law Enforcement Planners (OALEP) to become an official IALEP chapter.
- The existence of several planners' groups that have expressed interest in the possible pursuit of IALEP chapter status, including Virginia and possibly North Carolina.
- Marketing and outreach ideas both as IALEP presenters, and vendors;
- Development of an IALEP shop, where members can purchase IALEP gear;
- A bylaws change involving a slight change in the wording regarding the remittance of dues to the chapters by the Treasurer from quarterly to annual;
- Establishment of e-mail voting considerations and Listserve protocol;
- Procedures for maintaining planners' certifications once they are awarded, to keep them strong and marketable.

We are also working towards developing a way to reach the untapped market of students. As

President Ken Hailey stated at the meeting, "Nobody grows up to be a police planner." The Scottsdale Conference will be used as a vehicle to poll any attending students about their ideas.

We continue to look for ways to update and enhance the IALEP website. Anyone who is well versed in websites, their design, security considerations (including credit card transactions) is encouraged to speak up and add their voice to the discussions. Specifications for our dream website are being developed to provide a good starting point. Submit any of your ideas to Joe Bui.

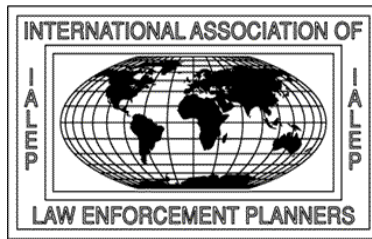

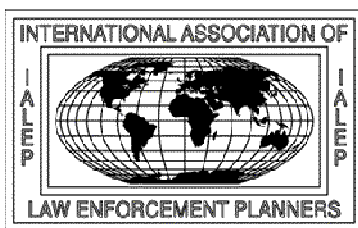
